Linda Talbott made a motion to approve the agenda with the omission of item 6-Community Center Update; Darla Reppe seconded it. Five voted aye.

For Public Input – Vickie Larsen addressed the Council regarding the Chief of Police advertising; Kerry Hedden addressed the Council with positive comments regarding Austin Schuller as a Police Officer, Linda Talbott shared received comments regarding the weeds at Alcester EMS Building. This concluded Public Input.

Jeff Nielsen and Sherry Oswald, Total Stop Food Store, addressed the Council with a request and completed Uniform Alcoholic Beverage License Application to allow Total Stop to sell Package Liquor — Off Sale. Jeff Nielsen presented information of TAMS training for employees and guidelines he follows in his other locations. Mr Nielsen answered questions asked by the Council. Dave Larsen made a motion to approve a Public Hearing for Tuesday, July 13, 2021 at 6:15 pm for the consideration of a Package Off Sale Liquor License to Total Stop; Brian Johnson seconded it. Five voted aye.

For Street Improvements – Lonnie Johnson presented the Council with two bids for additional street repairs. The Chip Sealing project has been completed for 2021. The quoted repairs involve either geogrid mat/gravel or laying of asphalt on Union Street, 3rd Street and 4th Street. Darla Reppe made a motion to approve the Asphalt Surfacing of portions of Union Street, 3rd Street and 4th Street, Daryl Stephenson's Asphalt, \$27,000, GF; Brian Johnson seconded it. Five voted aye.

For Department Head Updates: Police-Interim Chief Schuller is back from Vacation and PD truck is in for repair; Street: Lonnie Johnson is addressing the weeds in the gutters; Cemetery-the Council requested Parker Dooley to seek tree replacement for the Cemetery; Library-Summer Reading is going good; Finance Office-New Golf Course Cash Register is installed and operational.
