REGULAR MEETING OF THE ALCESTER CITY COUNCIL

The Alcester City Council held their regular City Council Meeting on Monday, November 7, 2022. Lukas Driesen made a motion to approve the agenda; Darla Reppe seconded it. Three voted aye.

Kyle VandenHull made a motion to approve the minutes of the October 10 and October 24, 2022 meetings; Lukas Driesen seconded it. Three voted aye.

For Public Input – Vickie Larsen addressed the Council with concerns of sewer backup, an unemployment claim, and polling place location. Gordon Richard addressed the Council with comments regarding the Alcester signs on the north and south end of town. This concluded Public Input.
